**Guarantor Criteria**

**A. Professional Person**

- Must have known the minor personally for at least 2 years, be a Canadian Citizen, and be one of the following: Chiropractor; Judge, Magistrate, Police Officer (RCMP or Municipal Police); Lawyer (member of a provincial bar association); Mayor; Medical Doctor or Dentist; Minister of Religion authorized to perform marriages under provincial law; Notary Public; Optometrist; Person occupying a senior administrative position or teaching appointment at a university or community college; Pharmacist; Postmaster; Principal of a secondary or primary school; Professional Accountant (member of APA, CA, CGA, CMA, RPA); Professional Engineer (PEng); signing officer of a bank, trust company or credit union; Veterinarian; Elected or appointed Indigenous band official (Band Chief, Band Councillor, or Band registration administrator).
- To know you personally means the guarantor is able to confirm aspects of your personal attributes such as name, approximate age, place of birth, physical description and some personal history such as occupation and place of residence.

**B. Employer**

- Must be minor's current employer and have employed the minor for a minimum of 2 years.

**C. Social Worker, Financial Assistance Worker or Immigration Officer**

- Must have been the minor's Social Worker, Financial Assistance Worker or Immigration Officer within the past 6 months and can confirm the minor is not a ward of the government.
