

Add a related individual as owner to a Replica/Constructed Collector Motor Vehicle

This form is to be used only to add a related individual to an approved and actively licensed replica/constructed collector motor vehicle. For this purpose, ICBC adopts the "related individual" definition as used in the Property Transfer Tax Act: (a) a person's spouse (legally married or living for a continuous period of at least 2 years with another person in a marriage-like relationship), child, grandchild, great-grandchild, parent, grandparent, grandparent, or sibling, or (b) the spouse of a person's child, grandchild or great grandchild, or (c) the child, parent, grandparent or great-grandparent of a person's spouse.

NOTE: Only the individual who was initially approved for the Collector program may add a related individual to the registered ownership of a replica/constructed collector motor vehicle.

If there have been any other changes or modifications to your vehicle since it was approved, then you must re-apply to the Collector program. If more than one related individual is to be added, each individual will need to complete this form. Keep the applications together so they can be processed at the same time.

In most cases there will be a **new plate fee** along with other fees (e.g. transfer of ownership/cancel policy) to add a related individual. If there are multiple owners added in the same transaction, the fees will apply to that transaction as opposed to the number of owners added.

STEP 3 — Vehicle use declaration

Collector vehicles must not at any time be used for business use or driving to or from, or part way to or from, work or school.

I confirm the following is true:

☐ The collector vehicle will be used solely for pleasure purposes, and cannot be used for general transportation, and will not at any time be used for driving to or from or part way to or from work or school or for any business use.

Note: Upon licensing and insuring and on subsequent renewals, you will be required to inform your Autoplan broker of the licence plate number of your non-collector, general transportation vehicle. If the only vehicle you have is your collector vehicle, you may still display collector plates on your motor vehicle, however you won't qualify for the reduced collector insurance premium. In addition, your replica/constructed collector motor vehicle must be rated for pleasure use only, and must not at any time be used for driving to or from, or part way to or from, work or school or for any business use

STEP 4 — Personal information

If your application is approved, a plate(s) will be sent to the broker noted below. If the plate(s) is not issued within 90 days, the broker will return the plate(s) to ICBC.

STEP 5 — Statement of Applicant

For Licensing Purposes:

I declare that:

- a) I am a resident of British Columbia;
- b) the motor vehicle described above is in, and will remain in, a condition that makes it of significant value to a collector of motor vehicles by adhering to the requirements provided in step 2 Vehicle Condition Requirements;
- c) when licensed as a replica/constructed collector motor vehicle, it will be used solely for pleasure purposes and will not at any time be used for driving to or from, or part way to or from, work or school or for any business use;
- d) my replica/constructed motor vehicle:
 - i. is, or will be, registered in BC; and
 - ii. was constructed by a person who is not a manufacturer of motor vehicles (e.g., hobbyist); and
 - iii. physically, functionally and mechanically resembles a 1942 or earlier model, i.e. engine placement must be correct.

OR

- ii. is, or will be, registered in BC; and
- ii. was manufactured in 1942 or earlier; and
- iii. has had its original body replaced by a person who is not a manufacturer of motor vehicles (e.g., hobbyist), and the replaced body resembles the original body of the motor vehicle.

For Insurance Purposes:

I declare that when the motor vehicle described above is licensed and insured as a collector vehicle at the reduced collector motor vehicle premiums:

- a) it will be used solely for pleasure purposes and not for driving to or from, or part way to or from, work or school or for any business use, and
- b) I will continue to maintain my vehicle in the condition that makes it of significant value to a collector or exhibitor of motor vehicles regardless of age at all times during the original and each subsequent licence/insurance policy term.

WARNING - INSURANCE COVERAGE AND CONTINUED ELIGIBILITY IN THE COLLECTOR VEHICLE PROGRAM

Insurance coverage may be forfeited if the vehicle described above is used contrary to the statements made above under "For Insurance Purposes." If these conditions are not met, I understand that the vehicle will not be eligible as a replica/constructed collector vehicle and the collector vehicle insurance rate class and that I must immediately contact an Autoplan broker to obtain appropriate licensing and insurance for my vehicle.

I acknowledge that if my vehicle is used for more than pleasure purposes at any time, after the initial application and approval as a Replica/Constructed Collector vehicle, my vehicle is no longer considered to be eligible for the Collector Vehicle Program.

Where the owner in this application gives false particulars to the prejudice of the corporation or knowingly misrepresents or fails to disclose in this application any fact required to be stated herein, or uses the motor vehicle contrary to the statement made above, insurance coverage may be forfeited. ICBC reserves the right to apply additional qualifying criteria when determining a vehicle's Replica/Constructed Collector Vehicle eligibility in accordance with the *Motor Vehicle Act* Regulations.

In signing this application, I declare that all the foregoing statements are true, and that I make these declarations with the intention that the Insurance Corporation of British Columbia will rely on the same.
