This application should be used to request licensing for your out of province vehicle that has previously been registered in B.C. as a Vehicle under Restoration after it passes the provincial mechanical safety inspection. You must bring your vehicle to your broker's office to have the VIN sighted and Step 4 of this form completed and signed by them.

**If your vehicle has been modified (any modifications to the suspension, drivetrain, engine, brakes, or body panels) from the original manufacturer's specifications please complete the Application to Register a Modified Motor Vehicle (MV1437) or a (MV1426) Application for Modified Collector Motor Vehicle Status. If your vehicle has not been modified from the original manufacturer's specifications you may be eligible for Collector Vehicle Status (form MV1425).**

## Step 1: Attachments

The following support documents must be attached to this application *where applicable* (submit copies and retain the originals for your records, attach a copy of a statutory declaration [MV1484] for any missing documents):

- I have attached a passed Vehicle Inspection Report from a Provincial Designated Inspection Facility (also keep a copy in the vehicle).
- I have attached my receipts, bills of sale and invoices for all improvements made to the suspension, drivetrain, engines, brakes, body panels, and fuel type, or any other major component parts.
- I have attached a weight scale certificate.
- I have attached photos of all visible VINS and photos of the vehicle as required (See Step 4 & 5).

## Step 3: Confirm motor vehicle age (confirm by checking box)

## Step 4: Vehicle Identification Number (VIN)

Inspect your vehicle and note all original manufacturers' public VINs and their locations. Current colour photos of all visible VINS required.

Note: Public VINS cannot be located underneath a vehicle; they must be clearly visible for sighting by a law enforcement officer.

If you're unable to locate an original manufacturer's public VIN on your motor vehicle:

- Complete an Application for a B.C. Assigned VIN (MV1325), available from your broker.
- Submit the MV1325 and a cheque or money order for \$25 (payable to ICBC) prior to submitting the MV1459.
