

# British Columbia Veterans Commemorative Association (BCVCA) Application for BC Veterans Licence Plate

The British Columbia Veterans Commemorative Association (BCVCA) is the sole veteran plate application approval agent on behalf of the Government of British Columbia. Approval in another jurisdiction does not qualify a person for B.C. veteran plates; use this form instead.

#### **ELIGIBILITY**

## Category One — Honourably Discharged Canadian Armed Forces Members

Second World War, Korean War, Gulf War, Balkan War 1990s, Afghanistan War, or a UN or NATO Peacekeeping Mission(s) and members of NORAD 1958 to 1970

# Category Two - Canadian Armed Forces Regular and Reserve Members

Honourably Discharged or currently serving members having successfully completed both basic training (BMQ) and having received a Military Occupational Classification (MOC) or a Military Occupational Structure Identification (MOSID)

## Category Three — Allied Veterans

Honourably Discharged Allied Force Members having served in UN or NATO Mission(s) allied with Canadian Armed Forces and members of the United States Armed Forces who served in Canada with NORAD 1958 to 1970

#### Category Four — British Commonwealth of Nations Veterans

Honourably Discharged Members of a British Commonwealth of Nations Armed Forces who qualify similarly to Category One Canadian Armed Forces Members

## Category Five - Police & Correctional Services Canada members who served a UN/NATO Mission

Municipal Police, Royal Canadian Mounted Police & Correctional Services Canada members who served under the Command of the Canadian Armed Forces in a UN or NATO Mission and have been Honourably Discharged from the specified UN/NATO Mission(s)

## PROOF OF MILITARY SERVICE - SELECT ONE

The following is a list of Military Service document choices required as Proof of Military Service. Choose **ONE** category applicable to your Service. Enclose a paper copy with your Application Form. Military Service documents will be returned to the applicant. **Do not** provide individual photos and copies of medals.

 Official documentary certification from the Officer-In-Charge of Human Resources stating enlistment and discharge dates of the Member who served under Canadian Armed Forces Command in a UN or NATO Mission(s) and that they were Honourably Discharged from the specified UN or NATO Mission(s)

#### **APPROVAL PROCESS**

#### Note:

- 1. Approved BC Veteran Licence Plate applicants are valid for the Veteran's lifetime.
- 2. Retain your approved application as proof of eligibility. Eligibility also may be verified by an Owner's Certificate of Insurance and Vehicle Licence (APV250) that confirms a BC veteran plate was previously issued for display on a vehicle solely registered in your name or by the broker confirming this ICBC record.
- 3. If additional plates are required, request them from an Autoplan broker; RE-APPROVAL IS NOT NECESSARY.
- 4. Veteran's name must appear on the vehicle registration.
- 5. Vehicle may be jointly registered. Retain this form after approval in case it is needed, for example you may need to show it to a broker if you later become the vehicle's sole owner, or if you want ICBC to issue additional veteran plates for a vehicle you solely own.
- 6. Complete all fields of the Application Form. Incomplete forms will be returned.
- 7. Copy the applicable Military Service Document(s) as proof of Military Service.

Step 1: Mail (by regular mail only) Application Form and a copy of Military Proof of Service to the BCVCA, PO Box 4903, Station Terminal, Vancouver, BC V6B 4A6. Also enclose a \$10.00 administration fee (cheque, money order, cash) payable to: British Columbia Veterans Commemorative Association

**Step 2:** Present your approved application form and your Owner's Certificate of Insurance and Vehicle Licence to your Autoplan broker to order your veteran plates. **RETAIN YOUR APPROVED APPLICATION FORM**.
