

Important — please read

Before completing this form, please ensure your vehicle meets ALL of the eligibility criteria in this application for a Replica/Constructed Collector Motor Vehicle. Incomplete applications will be rejected.

Regardless of the vehicle's age, it must meet ALL of the condition requirements to be eligible as a Replica/Constructed Collector Vehicle (see Step 2 of this application for condition requirements).

All Replica/Constructed Collector Motor Vehicles must have a BC Assigned VIN. Exception: Imported vehicles with Assigned VINs from other Canadian jurisdictions or US states.

To obtain a BC Assigned VIN please complete an Application for BC Assigned VIN (MV1325), available from your broker or icbc.com; and submit the application with a cheque or money order for \$25 (payable to ICBC).

Your replica/constructed motor vehicle will be registered with the year and make/model that the vehicle resembles and with an "altered" vehicle status.

Vehicles that **are not eligible**:

- motorhomes; and
- vehicles that are not fully assembled.

To qualify as a Replica/Constructed Collector Motor Vehicle, your vehicle **must**:

- be registered in BC; and
- be constructed by a person who is not a manufacturer of motor vehicles (e.g., hobbyist); and
- physically, functionally and mechanically resemble a 1942 or earlier model, e.g., engine placement must be correct.

OR

- be registered in BC; and
- have been manufactured in 1942 or earlier; and
- have had its original body replaced by a person who is not a manufacturer of motor vehicles (e.g., hobbyist), and the replaced body resembles the original body of the motor vehicle.

Eligibility Criteria

STEP 1 – Replica/Constructed Collector Vehicle Information

Your vehicle must meet one of the following options or do not submit this application.

My Replica/Constructed Collector Motor Vehicle:

- is, or will be, registered in BC; **and**
- was constructed by a person who is not a manufacturer of motor vehicles; **and**
 - physically, functionally and mechanically resembles a 1942 or earlier model, e.g., engine placement must be correct.

OR

- is, or will be, registered in BC; **and**
- was manufactured in 1942 or earlier; **and**
 - has had its original body replaced by a person who is not a manufacturer of motor vehicles (e.g., hobbyist), and the replaced body resembles the original body of the motor vehicle.

STEP 2 – Vehicle Condition Requirements

Regardless of the vehicle's age, it must meet ALL of the condition requirements to be eligible for the Collector Motor Vehicle Program.

My vehicle is in the following condition (all items below must be met and be checked off or the application will be rejected):

- Vehicle exterior** – My vehicle's exterior is clean, detailed and in excellent original or restored condition with no dents, scrapes, chips, paint blemishes, bubbling, rust, or visible primer.
- Vehicle interior** – My vehicle's interior is clean, detailed and in excellent original or restored condition with no tears, stains, or significant wear. Minor neat repairs to the original upholstery are acceptable.
- Vehicle repairs** – All repairs to the vehicle are completed according to professional practices and standards.
- Convertible top** – If applicable, my convertible top has no damage and is in good working order.
- Engine/Engine compartment** – My engine and engine compartment is clean and detailed with no damaged, deteriorated or rusted parts.
- Stickers and advertising** – My vehicle has **no stickers or advertising** of any kind. Exceptions are allowed to show affiliation with a collector vehicle club or for original dealer nameplates or decals that were dealer or factory installed.

STEP 3 – Vehicle Use Declaration

Collector vehicles must not at any time be used for business use or driving to or from, or part way to or from, work or school.

I confirm the following is true:

- My collector vehicle will be used solely for pleasure purposes, and cannot be used for general transportation, and will not at any time be used for driving to or from or part way to or from work or school or for any business use.
- I own or lease a **non-collector**, general transportation vehicle or I am the assigned operator of a company vehicle that is registered, licensed and insured in B.C. as my non-collector, general transportation vehicle.

Note: Upon licensing and insuring and on subsequent renewals, you will be required to inform your Autoplan broker of the licence plate number of your non-collector, general transportation vehicle. If the only vehicle you have is your collector vehicle, you may still display collector plates on your motor vehicle, however you won't qualify for the reduced collector insurance premium. In addition, your replica/constructed collector motor vehicle must be rated for pleasure use only, and must not at any time be used for driving to or from, or part way to or from, work or school or for any business use.

STEP 4 – Vehicle Photographs

Applications submitted that do not meet all the listed photograph requirements will be rejected. Photos will not be returned. Every new application will require new photos.

You will be required to provide additional close up photographs if the photographs you submit do not provide clear detail of your vehicle's condition. Please visit the Collector Vehicles webpage at icbc.com for examples of good quality photographs.

All images **MUST** be:

- taken within 90 days of mailing your application
- of the current vehicle condition and equipment;
- taken when the vehicle is clean and dry;
- taken in a well-lit area (no shade/shadows);
- taken straight on, and not on an angle;
- clear and detailed;
- in colour;
- high resolution and unaltered;
- a minimum size of 4" x 6";
- printed on glossy photo paper.

Close-up detailed colour photographs of the following:

Exterior

- public vehicle identification numbers (VIN)
- each exterior body panel including roof, hood, trunk lid
- entire front view*
- entire rear view*
- entire right side*
- entire left side*

- trunk with lid open
- box with tailgate down
- engine compartment
- if convertible model, convertible top up

* May be taken as 2 photos. Photos must overlap to ensure full vehicle area coverage/no vehicle area omitted.

Interior

- entire dashboard (including radio and steering area)
- all interior door panels
- all seats (non-factory seat covers removed)
- all floor areas (loose floor mats removed)
- headliner (not convertible)

Motorcycle Photographs

Close-up detailed colour photographs of the following:

- public vehicle identification numbers (VIN)
- entire right side
- entire left side
- front
- rear
- seat(s)

STEP 5 – Personal Information

If your application is approved, a collector plate will be sent to the broker noted below. If we don't have all of this information, we won't know who to send your plate to. If the plate is not claimed within 90 days, the broker will return the plate to ICBC.

STEP 6 – Statement of Applicant

For Licensing Purposes:

I declare that:

- I am a resident of British Columbia;
- the motor vehicle described above is in, and will remain in, a condition that makes it of significant value to a collector of motor vehicles by adhering to the requirements provided in step 2 Vehicle Condition Requirements;
- the attached colour photos are of my replica/constructed motor vehicle and accurately show the current condition of the vehicle;
- when licensed as a replica/constructed collector motor vehicle, it will be used solely for pleasure purposes and will not at any time be used for driving to or from, or part way to or from, work or school or for any business use;
- my replica/constructed motor vehicle:
 - is, or will be, registered in BC; and
 - was constructed by a person who is not a manufacturer of motor vehicles (e.g., hobbyist); and
 - physically, functionally and mechanically resembles a 1942 or earlier model, i.e. engine placement must be correct.

OR

- is, or will be, registered in BC; and
- was manufactured in 1942 or earlier; and
- has had its original body replaced by a person who is not a manufacturer of motor vehicles (e.g., hobbyist), and the replaced body resembles the original body of the motor vehicle.

For Insurance Purposes:

I declare that when the motor vehicle described above is licensed and insured as a collector vehicle at the reduced collector motor vehicle premiums:

- it will be used solely for pleasure purposes and not for driving to or from, or part way to or from, work or school or for any business use, and
- I own or lease another licensed non-collector motor vehicle or motorcycle, or have a licensed non-collector motor vehicle or motorcycle as a company assigned vehicle that is insured for general transportation purposes in one of the following rate classes 001, 002, 003, 004, 005, 007, 011, 012, 013, 014, 015, 017, 021, 022, 023, 024, 027, 310 to 314, or 320 to 324.
- I will continue to maintain my vehicle in the condition that makes it of significant value to a collector or exhibitor of motor vehicles regardless of age at all times during the original and each subsequent licence/insurance policy term.

WARNING – INSURANCE COVERAGE AND CONTINUED ELIGIBILITY IN THE REPLICA/CONSTRUCTED COLLECTOR VEHICLE PROGRAM

Insurance coverage may be forfeited if the vehicle described above is used contrary to the statements made above under "For Insurance Purposes." If these conditions are not met, I understand that the vehicle will not be eligible as a replica/constructed collector vehicle and the collector vehicle insurance rate class and that I must immediately contact an Autoplan broker to obtain appropriate licensing and insurance for my vehicle.

I acknowledge that if my vehicle is used for more than pleasure purposes at any time, after the initial application and approval as a Replica/Constructed Collector vehicle, my vehicle is no longer considered to be eligible for the Collector Vehicle Program.

Where the owner in this application gives false particulars to the prejudice of the corporation or knowingly misrepresents or fails to disclose in this application any fact required to be stated herein, or uses the motor vehicle contrary to the statement made above, insurance coverage may be forfeited. ICBC reserves the right to apply additional qualifying criteria when determining a vehicle's Replica/Constructed Collector Vehicle eligibility in accordance with the Motor Vehicle Act Regulations.

In signing this application, I declare that all the foregoing statements are true, and that I make these declarations with the intention that the Insurance Corporation of British Columbia will rely on the same.
