



## Vehicle licensing & insurance bulletin

# Disruptions from floods and infrastructure damage

Disruptions from recent extreme weather events are interfering with document and service delivery to motorists. To help mitigate this, the measures ICBC introduced at the start of the COVID pandemic continue, and new information is offered about driver licensing documents.

### Procedures & implications

As described in [bulletin 28](#), motorists can engage in vehicle licence and insurance transactions with their broker by telephone and e-mail. Brokers can send new documents, decals or licence plates by mail or courier, or hold the item(s) for the motorist to pick-up.

If delivery delays occur after licensing or insuring, motorists may be temporarily operating with home printed temporary number plates displayed in their vehicle windows, digital or home-printed B.C. vehicle registration, licence and insurance certificate, and recently expired validation decals.

### DL advice

Reminder letters to renew driver licences (DLs) may be delayed, and given emergency impacts some drivers may forget to renew their DL.

Mail delivery of DLs may be delayed if delivery is to, or through, areas that are impacted. As a result, some drivers may only have in their possession:

- an expired interim paper DL if they renewed their DL in the last 60 days and their new photo DL is delayed in the mail, and
- an expired DL card if they renewed over the phone within the last 60 days.

If a driver has renewed their DL but only has possession of an expired DL, the CPIC screen will reflect DL validity.

## Considerations

Law enforcement, bylaw officers, and anyone else it may concern are advised of these temporary procedures to help inform their decisions in applying related statutes, bylaws or rules for British Columbians.

In all cases, ICBC systems will contain up-to-date information and law enforcement can access this through CPIC or other means.

ICBC will issue another bulletin to advise our partners when these measures change or come to an end.
